### Submission of Manuscripts

- The *JHR* has no submission fee.
- A submission is not complete until both the electronic and hard copies are received.

**REQUIRED**—The *JHR* may return manuscripts to authors who fail to comply with these requirements.

### Electronic Copy—General

- Submit via email, as two attached files, one consisting of the paper itself and one of the title and authors names (see below)
- Please name the electronic files with useful identifying information, such as authors' name or words from the title, and whether it is the paper or the title page (for example, smith\_paper.pdf and smith\_title.pdf).
- In your covering email include the names of the authors, title of the paper, and address of the corresponding author including phone and fax numbers.

### Electronic Copy—Title Page

- Names of authors, title of manuscript, addresses Send as Word, Word Perfect, or PDF.

### Electronic Copy—Paper

- Send as a PDF file with no identifying information. Check the Document Summary (Ctrl +D or File, Document Properties, Summary) for any identifying markers. There should be nothing in the fields listed in the Document Summary.
- The paper—including all tables, figures, appendixes—should be in one continuous file.
- If you have tables, figures, or any other additional materials that you can not attach to the paper prior to converting it to a PDF, please PDF them as a second file.
- If you cannot create a PDF file, email the documents (the title page and the paper) in MS Word format. Do NOT send separate Excel spreadsheets with tables. Do NOT send individual tables.

### Hard Copies

Send **Two** hard copies of each manuscript following in this format:

- Single sided pages.
- Double-spaced lines throughout all text and endnotes
- One-inch or wider margins
- **All** text and notes in 12-point type or larger
- Abstract of no more than 100 words

### *JHR* Policy on Replication and Data Availability

1. Manuscripts submitted to the *JHR* will be judged in part by whether they have reconciled their empirical results with already published work on the same topic.
2. Authors of accepted manuscripts will be asked to make their data available to other analysts from a date six months after *JHR* publication for a period of three years thereafter. Exemption from this requirement may be requested.
3. The *JHR* welcomes replication, fragility, and sensitivity studies of empirical work that has appeared in the *JHR* in the last five years or empirical work judged by the editors to be important to the fields covered by the *JHR*.
